#### **TREASURER'S REPORT 2018**

The Audited Financial Statements for Bow Cliff Seniors are available for your review at the Centre or on our website for the year ending December 31, 2018. The Statements were prepared using the Canadian accounting standards for not-for-profit organizations and were audited by Deborah V Walker Professional Corp.

2018 was a very challenging year financially for our organization as we grew into our new facility and made difficult adjustments to maintain a balanced operation going forward. We reduced our operating costs in the fall through staff adjustments, a reduced cleaning schedule and eliminated programming that was not generating adequate revenue to cover its costs, while maintaining core programming that is popular with our members. These operational adjustments will save us approximately \$20,000 annually.

Our organization is critically dependent on continued support from many municipal, provincial and federal grants, as well as individual and community donations. Almost 50% of our 2018 annual revenues came from various government support programs. We received FCSS funding of \$100,500 during 2018 with a similar annual commitment for the next 3 years. We did not have a casino in 2018 but are looking forward to our casino proceeds this spring, which will help in supporting our organization over the next 24 months. Without the continued funding from FCSS and AGLC casinos, our organization would not be viable.

Facility rental revenue has grown significantly over the past year and has become a vital revenue source to help sustain our operations. These increased rentals also have contributed to introduce our club and programming to a wider population, and we expect this will improve our total membership.

We are most grateful to our members and the general public for their generous donations over the past year. We know that there are many worthwhile charities throughout the City. However, we need your help! As a nonprofit dependent on government funding, donations allow our organization the ability to continue to offer cost effective and supportive programs. As a registered charity, we can issue tax receipts for donations and I encourage our members to consider Bow Cliff 50+ as part of your donation destination.

As a governance Board, we are committed to maintaining sustainable funding and programs for our membership. We are appreciative for the continued support of our members, partners, funders, donors, sponsors and our community and look forward to a successful 2019.

It has been a pleasure to serve as your Treasurer.

We are most grateful to FCSS and AGLC which provided approximately 50% of our funding. Our membership has remained stable throughout 2018 with over 400 total members.

Throughout 2018 we continued to offer our core programming including Art, Music, Bridge, Wednesday Lunch and Bingo and recently introduced Crib on Thursday afternoons to maintain a full week of programs popular with our members.

One of the highlights for the year was our Christmas luncheon which was a spectacular success with over 100 in attendance, all enjoying a homemade turkey dinner prepared by our dedicated and talented lunch bunch crew.

Our facility has become more popular with local organizations and associations which has provided us with a tremendous rental revenue source. These rental revenues are critical to allow us to continue to offer cost effective programming at our club.

Thank you to our joint facility partners, the Calgary Lawn Bowling Club for their continued support and congratulations on hosting a very successful 2018 Canadian Senior Triples national championship. It was great to hear so many compliments about our facility from people from around the country. I also want to thank the Hellenic Seniors for once again hosting a wonderful free lunch for our members last fall.

Our organization is blessed to have incredible staff and volunteers (too numerous to mention by name). We appreciate your continued support and generosity of time.

Thank you to Councillor Evan Wooley, MLA Brian Malkinson and MP Ron Liepert and their staff for their continued support and a special thanks to Heather Gibbons, our NPC from the City of Calgary.

On behalf of Donnell, Danielle, Brad and myself, we want to thank our Board and Executive for their faith and trust in us and we look forward to a successful 2019.
