Newsletter from MP Ron Liepert for July 2019

The House of Commons has now concluded sitting for this mandate and the focus over the next few months will be the federal election on October 21. Canadians will have an opportunity to pass judgement on the success of the government over the past four years and whether the Liberals should be re-elected.

Canadians will decide whether balanced budgets are important or whether increased spending and close to \$80 billion added to the debt is acceptable.

Canadians will also chose whether they prefer a carbon tax which is being imposed on Alberta and many other provinces that have chosen not to implement a provincial tax. Environmental policies will likely be a ballot box choice as Canadians will determine who has the best policy to deal with growing concerns about our land, water and air.

This election will also be an opportunity for Albertans to express their satisfaction or displeasure with the government's handling of energy issues. The topic of pipelines dominates every conversation in the province these days and many electors will make their voting choice based on which party has the best policy to deal with this issue.

Canadians will also be passing judgement on whether issues such as SNC Lavalin, handling of the Mark Norman situation and a variety of ethical breaches are important factors when marking a ballot.

Canada's international policies have also dominated much of the past four years. The U.S. has become much more protective under the Trump administration and the ongoing trade disputes with China are seriously impacting our agriculture exports. Illegal border crossing from the U.S. which is causing long delays in approvals for those attempting to navigate the system legally still remains unresolved.

Constituents should engage in discussions with friends and family over the next few months to be fully informed of the government performance over the past four years and whether another mandate is deserved or whether policies enunciated by one of the other parties makes them more deserving of a chance to govern.

When it roars, stay indoors

Summer is a wonderful time of year to spend time outside under the warm sun, but it's also the most active storm season in Calgary. While storms can be mesmerizing and exciting, they can also be very dangerous.

"Calgary is prone to strong and sometimes dangerous summer storms," says Tom Sampson, Chief of the Calgary Emergency Management Agency. "Keep yourself, your family and your property safe during a summer storm by signing up for emergency alerts, making an emergency plan, and having a 72-hour kit."

In addition to thunder, lightning, rain, and wind, summer storms often bring hail which can damage houses and cars and cause injuries. Protect your home and property by parking under shelter, secure items that might blow away, and remove weak branches and trees.

Public weather alerts for Alberta and Alberta Emergency Alerts let the public know when a strong storm is coming. A "severe weather watch" means the conditions favour a certain type of hazardous weather, and a "severe weather warning", means that the weather event will happen in the next 30 minutes.

The best place to be during a storm is in an enclosed building or hard topped vehicle. Stay away from high ground, isolated trees or telephone poles, picnic shelters and open spaces, to avoid being hit by lightning. Keep yourself and your pets inside until the storm has passed.

BBB warning of Top 10 Seniors Scams

Better Business Bureau is seeing where seniors are falling victim to scams and advising on how to avoid them. The following are the most common ones that target seniors with their too-good-to-be-true deals.


